Sealed tenders are invited under TWO BID SYSTEMS (A) Technical Bid & (B) Financial Bid from the reputed and experienced interested suppliers for supply of Approx. 12000.00 Nos of 30-35 kg capacity, Size-85x54 cms outer, +/-1cm DW Jute Tarpaulin Bags, Printing of bag will be done on both sides in three/four permanent colours by screen printing as per matter to be provided by the Regional Office, NSC Ltd, Kolkata. The bags shall be double stitched, double locked by inside folding for FOR delivery at destination including of all tax/GST. The interested parties may obtain tender document from Regional Office, National Seeds Corporation Limited, Kolkata, up to 2:00 PM of 03-05-2018 on payment of Rs. 500/- (Rupees Five Hundred only) non-refundable. Duly filled in tenders will be received up to 02:30 PM on 03.05.2018 at NSC Kolkata. Tenders will be opened on the same day I.E. 03-05-2018 at 03:30 PM at Block-AQ, Plot No.12, Salt Lake, Kolkata. INVITATION OF COMPETITIVE BID FOR PURCHASE 30-35 kg capacity DW Jute Tarpaulin bags.

National Seeds Corporation Limited(NSC) intends to purchase following Numbers/quantity of 30-35 kg capacity, Size 85x54 cms outer, +/-1cm of DW Jute Tarpaulin bags, bag shall be made of jute Tarpaulin fabric Part-II both side printing with three/four colours. The bags shall be double stitched, double locked by inside folding with unbleached 9 cord no.2 closing thread and number of stitches will be four in 2.5 cm(1”) from reputed Bag Supplier through sealed tender under two bid system.

TWO BID SYSTEMS:

Two separate sealed envelopes should be prepared as per the details given here under;

1. ENVELOPE NO. 1 (SEALED)

This envelope should be addressed to **Regional Manager** and marked as “**ENVELOPE NO.1–Technical Bid For Supply of DW Jute Tarpaulin bags, 30-35 kg capacity**” and should contain EMD and Technical bid as per format “Part A” duly filled in and printed on letter head of tenderer. (Tenderer should invariably mention their name and complete address etc. on left hand side of envelope for clear identification)

2. ENVELOPE NO. 2 (SEALED)

This envelope should be addressed to **Regional Manager**, NSC, Kolkata and marked as “**ENVELOPE NO-2 - Financial Bid for Supply of DW Jute Tarpaulin bags, 30-35 kg capacity**” and contain the rates as per proforma “Part B” duly filled in printed on letter head of tenderer. (Tenderer should invariably mention their Name and complete address etc. on left hand side of envelope for clear identification).

3. Both envelopes should be placed in one big sealed envelope superscribing “**Tender For Supply of DW Jute Tarpaulin bags, 30-35 kg capacity Due For Opening On -03-05-2018**”. The sealed tender document, sealed with red lac, should be delivered in the office of the **Regional Manager**, NSC, Kolkata. Tenderer must affix seal with red lac and write address on each envelope.

TERMS AND CONDITIONS:

1-The tenderer shall present the offer of quantity of above item on his Letter-head using offer formats.

2-Rate shall be quoted in per bag for **FOR delivery** including all tax/GST basis .

3- The rate shall be all inclusive and no other claim on account of taxes,GST etc.,if any leviable shall be entertained.

4-The quoted rates per bag should be for FOR supply to Area Manager, Area Office, NSC Ltd,plot no-12,Block-AQ,Sector -V, Salt Lake City, Kolkata W.B.

5-The tender shall be accompanied with interest free EMD of **Rs.15000/-(Rupees Fifteen Thousand)** in the form of Demand Draft &Through NEFT /RTGS drawn in favour of '**National Seeds Corporation Limited**', payable at **Kolkata**.Tender without EMD will be rejected. EMD of unsuccessful tenderers, except the lowest bid(s) whose offers total to 100% tendered quantity, will be returned through A/C payee cheque within 45 days of tender opening. Outstanding amount, if any, from the tenderer with NSC will not be considered as EMD.

6-Tenders in sealed envelope will be received at **National Seeds Corporation Ltd., NSC, Kolkata till 02:30 PM up to 03.05.2018** and technical bids as well as financial bids will be opened on the same day and place at **03:00 PM** in the presence of those tenderers, who may wish to be present. Tenders received after the due date and time will be rejected. Financial bids will be opened of only those, whose technical bids are technically qualified after Technical Evaluation by the Technical Bid Evaluation Committee. The decision of the Technical Bid Evaluation Committee will be final and binding.

7-Price negotiation : In the event of quoted price not being justifiable by management , negotiation can be called for with L-1 party.

8.In case L-1 bidder fails to supply the total required quantities, the NSC will split the order among next two or more tenderers and any counter offer made thereafter by L-2, L-3, etc. shall not be treated as deemed to be negotiations as stipulated in point 7 above.

9.In case L-1 bidder fails to supply the DW Jute Tarpaulin bags due to any reason then NSC reserves the right to place order with L-2 party. In such cases the EMD of L-1 party will be forfeited and the party will be **black listed** by NSC.

10-The tenderer will submit a properly labeled/sealed **representative sample of one number bag without prenting** alongwith the sealed tender.

11.The tenderer's offer shall be valid for at least for 90 days and supply will be completed within **12 days** after receiving of purchase order issued by Regional Office, NSC Ltd, Kolkata.

11.(a) NSC will issue letter of Intent / Purchase order to the successful bidders immediately on taking decision on the offers. NSC shall also issue need based demand Letter/ despatch order. Supply Shall commence on 12 day of demand letter/despatch order issued by NSC and should be completed **within stipulated period or cut-off date.**NSC will not be responsible for supply beyond the stipulated time.

(b).The supplier shall sign an **agreement** on receipt of Letter of Intent/ Purchase Order within 5 days and deposit remit security deposit as per clause 13 of terms and condition.

12.Failure to deliver less than 90% of approved quantity, penalty shall be imposed by NSC @ 10% of the value of the shortfall beyond 90% in the supply

at the rate agreed to. For delayed supplies, a penalty of Rs. 2% of value of Jute bags delivered late per week or part thereof limited to 5%. However, NSC shall free to take other remedial measures like cancellation of order, purchase from other source at the risk & cost of supplier.

13.The successful tenderer upon being called to do so, shall remit an interest free **Security Deposit of Rs.50,000/-(Rs.FiftyThousand) Only** in form of RTGS/Demand Draft drawn in favour of '**National Seeds Corporation Limited**' payable at **Kolkata.**This deposit shall be remitted within five working days from the date of fulfilment of NSC's purchase order. Failure to remit the Security Deposit will imply forfeiture of EMD. The EMD of successful tenderer may be adjusted against the security deposit.

14.The successful tenderer shall at his own cost will execute **an agreement** with NSC on non-judicial stamp paper of required value preferably Rs. 100/- for arranging the supply as per these terms and conditions, signing on each page of the Terms and Condition and submit the same to NSC alongwith the Security Deposit.

15.Tenderer failure to arrange the supply as per the Terms & Conditions will entitle NSC to cancel the order and arrange the supply of material from the next party in the tender at the cost and risk of the defaulting tenderer.

16.If required, NSC may repeat the order for the additional quantity within two months from the date of Security Deposit remittance with mutual consent.

17.The payment will be released through RTGS/Crossed A/C payee cheque within 25 days after the receipt of bills verified by Area Office of receiving unit subject to fulfilling the requirements set out in the Terms & Conditions.

18.NSC will retain the Security Deposit for 60 days from the date of last supply as performance guarantee.

19.In the event of any dispute/complaint with reference to the DW Jute Tarpaulin bags quality, if supplier is unable to prove/establish genuineness of the supplied Jute Bags, he shall bear the loss/damage, if any, sustained by NSC to the relevant extent.

20.Conditional offers shall not be accepted and the tenderer shall not impose any additional term & condition.

21.NSC reserves the right to accept/ reject any or all the tenders without assigning any reason whatsoever. The bids of two or more partership firms having same parteners will not be entertained at one time in one tender. Such partership firms to participate in NSC tender in only one name at one time in one tender.

22.In the event of any question/ dispute or difference arising between NSC and the supplier on any matter covered by these Terms and Conditions or arising directly or indirectly there from or connected with these Terms & Condition in any manner the matter shall be referred to the Sole Arbitrator who may be appointed by the CMD, NSC or by any other competent officer who at the relevant time is occupying the highest office in NSC at New Delhi and has been delegated with such powers. The tenderer shall have no objection in this regard. Also the Courts of Delhi/New Delhi alone shall have jurisdiction to adjudicate thereon.

23.Tenderer has to mentioned the full address of company/firm along with registration number,Pan card number,GST number,service tax number, addhar card number along with photo copies of same to be provided.

24.The Bag shall be made of jute tarpaulin fabric part-II .

25.The Size of DW Jute Tarpaulin bags of 30-35 kg capacity 85x54 cm outer,+/-1cm. tolerance with the minimum 1” stitching inside fold/each side on raw edges. Weight jute tarpaulin Fabric(double warp) gram/m² -407 gram/m²,tolerance,+33/-8 as per IS:7407 (Part-II)-1980.

26.Weight of bag-400 gm +/-3% at 16% moisture content ,Ends/dm85+/-2 & Picks/dm 39 +/-2.

27.Breaking load (Reveled strip method (10X20 CM), kgf minimum,warf strength -185 kgf 7 weft strength-100kgf.

28.Stitching of Bag:-

The bags shall be double stitched, double locked by inside folding with unbleached - cord no-2 closing thread and number of stitches will be four in 2.5 cm(1”).

29.Printing of bags will be done on both side in three/four permanent colour by screen printing as per matter to be provide by the corporation. The cost of screens will be met by the supplier.

30.Confirming to all other specification as per equivalent ISI norms.
